## **CIB** issues new high-yield CDs

Commercial International Bank [**COMI**] has issued new three-year high-yield CDs that offer 22% p.a. However, the bank has set a minimum ticket size of EGP3mn. COMI has also issued three-year 17% p.a (paid monthly) and 18% p.a (paid annually) with a minimum ticket size of EGP1mn. (Economy Plus)

## New high-yield CDs proceeds reach EGP67bn

The proceeds of the new three-year high-yield CDs that were issued a couple of days ago from the **National Bank of Egypt (NBE)** and **Banque Misr**, reached EGP67bn on the very first day. (Economy Plus)

## Egypt's external debt increased by 5.1% q/q

According to the **Ministry of Planning**, **Egypt**'s external debt increased by 5.1% q/q to USD162.9bn in Q2 FY23. (**Disclosure**)

## Egyptian Ministry of Agriculture releases amounts of corn and soybean

Last week, the **Egyptian Ministry of Agriculture** released 114,000 tons of corn worth USD41mn and 45,000 tons of soybeans worth USD34mn, in addition to fodder worth USD5mn. (Al-Mal)

## ORWE's OGM approved paying cash dividends in May

Oriental Weavers Carpet [**ORWE**] OGM approved distributing a cash dividend of EGP0.60/share in May 2023, implying a 4% yield. (**Company disclosure**)

## OFH to reduce paid-in capital through treasury share cancelation

Orascom Financial Holding's [**OFH**] BoD held on 2 April 2023 agreed to reduce paid-in capital by EGP138mn through the cancelation of treasury shares amounting to 446mn shares (i.e. 8.5% of issued shares) which were bought back three months ago. Accordingly, OFH's paid-in capital post the cancelation will be EGP1.5bn distributed over 4.8mn shares at a par value of EGP0.31/share. (Company disclosure)
